COVERAGE

Voluntary group critical illness insurance provides a fixed, lump- sum benefit upon diagnosis of a critical illness, which can include heart attack, stroke, paralysis and more. These benefits are paid directly to the insured and may be used for any reason, from deductibles and prescriptions to transportation and child care.

ELIGIBILITY

Each Active Full-Time Employee working 20 hours or more per week, except for any person working on a temporary or seasonal basis.

Dependents: You must be insured for your Dependents to be covered. Dependents are:

- Your legal spouse or your domestic partner. Spouse must be under age 70 at date of application. Coverage terminates at age 75.
- > Your dependent children from birth to 26 years.
- A person may not have coverage as both an Employee and Dependent.

BENEFIT AMOUNT

Employee: Choose from a benefit of \$10,000 to a maximum of \$50,000 in \$10,000 increments.

Spouse: Choose from a benefit of \$10,000 to a maximum of \$30,000 in \$10,000 increments, not to exceed 100% of approved employee amount.

Child(ren): 100% of approved employee amount up to a maximum of \$50,000.

Employee: \$30,000 Spouse: \$30,000 Child(ren): \$50,000

CONTRIBUTION REQUIREMENTS

Coverage is 100% Employee Paid.
